

# Information document pursuant to and in accordance with Article 13 of Regulation (EU) 2016/679 (GDPR)

In compliance with the provisions of Article 13 of Regulation (EU) 2016/679 (GDPR), we provide you with the necessary information regarding the processing of personal data.



# Processed personal data.

**Personal data:** any information relating to an identified or identifiable natural person (data subject). An identifiable person is someone who can be identified, directly or indirectly, by specifically referring to an identifier such as name, identification number, location data, online identifier or to one or more factors specific to his/her physical, physiological, genetic, mental, economic, cultural or social identity – see Art. 4, par. 1, (1) GDPR.

# 2. PURPOSES OF THE PROCESSING AND LEGAL BASIS - DATA RETENTION PERIOD - NATURE OF THE PROVISION

• PURPOSES OF THE PROCESSING: Direct marketing.

These communications will be sent by email or made by telephone, also through automated means (SMS, social network messaging systems). You also have, in any case, the possibility of preferring to be contacted exclusively by traditional means, objecting only to receiving communications through automated means by writing to <a href="mailto:privacy@fondital.it">privacy@fondital.it</a>

- **LEGAL BASIS:** Your explicit consent to the processing of data for this purpose (Art. 6, paragraph 1, letter b GDPR)
- **PERSONAL DATA RETENTION PERIOD:** until revocation of consent. You may revoke your consent at any time by clicking on the "unsubscribe" button contained in any email or newsletter you receive or by writing to <a href="mailto:privacy@fondital.it">privacy@fondital.it</a>.
- THE PROVISION OF DATA FOR THIS PURPOSE IS OPTIONAL. If you do not wish to provide your data, it will not be possible for Fondital Spa to keep you constantly updated on offers and promotions reserved for its customers, nor will it be possible to use your data for market research and statistical and customer satisfaction analyses.



#### 3. RECIPIENTS OR CATEGORIES OF RECIPIENTS OF DATA

The personal data provided may be communicated to subjects who will process the data as processors and/or as authorised persons acting under the authority of the Data Controller, in order to comply with the existing contracts with the Company or for related purposes. In particular, data may be communicated to recipients belonging to the following categories:

- external subjects who manage / support / assist, even occasionally, the Data Controller in the management of the information system and telecommunications networks (including e-mail)
- Firms or companies in the context of assistance and consulting;
- authorities for the fulfilment of legal obligations and/or provisions of public bodies upon request.

#### 4.DATA TRANSFER TO A THIRD COUNTRY

#### 5. AUTOMATED PROCESS

We do not use decision-making processes based on automated processing, including profiling.



# **6.THE RIGHTS OF THE DATA SUBJECTS**

You may assert your rights as expressed in Articles 15 et seq. of EU Regulation 2016/679 by directly contacting the Data Controller using the contact details indicated above.

In particular, you have the right, at any time, to obtain access to your personal data from the Data Controller and request the Data Controller information relating to the processing, as well as to rectify, erase your personal data or restrict their processing and object to the processing carried out pursuant to Art. 6, paragraph 1, letter e) or f) GDPR. Furthermore, at any time, you have the right to withdraw the consent given without prejudice to the lawfulness of the processing based on consent before the withdrawal. You have the right to the portability of your personal data and in this case the Data Controller will provide you with your personal data in a structured format, commonly used and readable by an automated device. If you believe that the processing of your personal data by the Data Controller is in violation of the provisions of Regulation (EU) 2016/679, you have the right to lodge a complaint with the Supervisory Authority - Italian Data Protection Authority (<a href="https://www.garanteprivacy.it/">https://www.garanteprivacy.it/</a>).
